

# Greening of NCI 2017

## **Policy Statement**

- The National College of Ireland is committed to energy management and recycling for the improvement of our environment and efficiency.
- As a minimum NCI will comply with relevant legislation and regulations with respect to energy and recycling.
- NCI will avoid energy wastage, reducing emissions to the environment caused by energy consumption.
- NCI will reduce the amount of waste sent to landfill sites from the College on a weekly basis.

### Aims, objectives and targets

- To establish an effective energy and recycling Management system
- To monitor and control energy purchasing and use
- To monitor and control the amount of waste generated
- To improve staff awareness and operating practices in all areas of activity
- To reduce dependence on fossil fuel use through investment in increased efficiency and renewable energy
- To reduce energy consumption further by 20% over the next 3 years
- To reduce waste by 25% over the next 3 years

# Responsibilities and duties within the organisational structure

- The senior manager with overall responsibility for Energy and Waste management is Bertie Kelly
- The energy manager responsible for day to day energy management matters is Owen Delaney reporting to Bertie Kelly
- The energy committee will comprise of four representatives. Twice yearly meetings will be chaired by Bertie Kelly
- Line managers will be responsible for energy use in their own department

#### Resources

- Owen Delaney is appointed as our energy manager
- The energy manager will spend 3 days per month dealing with energy/waste management
- 10% of our annual energy expenditure will be invested in energy/waste efficiency improvements
- The energy team will comprise 3 staff, based within Premises/Facilities/Commercial Office

### **Reporting and communication procedures**

- Monthly meter readings will be taken by the Maintenance team and sent to the energy manager for analysis
- The energy manager will report on energy performance to the Executive Board
- The energy committee will report once yearly to the Governing Body via the Presidents report

## **Action Plans**

Each task will have its own action plan, Plans will be drawn up following a period of time to gather and evaluate information. PC, Monitor, data projectors and printer shut down at night and weekends

- Paper usage for all printing and copying (2 sides V single pages)
- Recycling of batteries, Ink cartridges, IT equipment and plastics
- Educational programme
- NCI Purchasing policy re; quantities, pallets, packaging
- Evaluate waste consumption and breakdown generating areas
- Boiler strategies and LPHW circuits
- CHW strategies and cooling circuits
- Investigate Harnessing Solar Energy
- PIR's in every room in College
- Residences converted to energy saving bulbs
- Window seals and Insulation in residences
- Costing on energy usage and ancillary equipment
- Recycling bins and centres around the buildings
- In 2016 NCI changed 100% of all lighting to low energy LED
- Water usage savers installed in all facilities

#### **Review process**

- The energy manager will monitor progress with the action plans and the wider aims and objectives
- The findings and recommendations will be presented to the Executive Board
- The policy document will be reviewed and updated annually
- A new action plan will be prepared each year for inclusion in the policy document
