You should provide evidence that to the best of your knowledge your idea/invention is not already on the market. The competition is open for entries from the 11th September 2015 to the 31st December 2015.

Awards

The competition prizes represent €250 gift vouchers awarded between October 2015 and January 2016. Additional prizes may be promoted and awarded throughout the duration of the competition at the discretion of the organisers. Where a winner is an employee of a participating institution and has received additional benefits-in-kind during the same financial year, the €250 prize may be subject to PAYE/PRSI.
