PET Project Manager

Background

National College of Ireland is consolidating its position in the area of Professional Education & Training (PET). As the economy improves the PET unit plans to expand on its existing and emerging industry relationships and partnerships (Sales Institute of Ireland, Irish Institute of Pensions Management, Finuas, Irish Computer Society, McDonalds, and Irish League of Credit Unions) to achieve the financial targets agreed in the current 5 year plan.

There are currently 3 key revenue streams for PET:

- 1. Personal Financial Planner (PFP) programmes
- 2. General PET programmes (with the above partnerships)
- 3. Labour Market Activation Funding (e.g. Springboard) programmes

In order to ensure all PET programmes are developed, maintained and updated in a way to ensure NCI is seen as a high quality and respected provider of professional education, it is now proposed to appoint a Project Manager to the PET unit. The role is key to the fulfilment of the college's strategic plan and represents an exciting opportunity for the right candidate.

Role and Responsibilities

This role will be responsible for ensuring effective organisation, design, delivery, and where appropriate further development of all professional education programmes. This will include, where industry partners can evidence a sustainable revenue stream, establishment of new programmes and relevant designations. A key component of this will be coordination between the PET unit and the relevant school. A significant part of the role will be the development and mentoring of the team of people who will deliver the various aspects of the programmes.

The job holder will also be responsible for working with relevant internal and external stakeholders to develop and manage the delivery of Continuing Professional Development (CPD) events for the PFP programmes and other programmes which may require a CPD element. They will manage the relationship between PET with the Programme Coordinator for PET programmes within the Schools.

- As the business world changes an appreciation of the business and technical requirements of developing or delivering programmes in an online or blended environment is needed of the role technology plays in both the delivery of programmes and as content on programmes
- In conjunction with the marketing and sales functions within NCI to build an awareness of college offerings across all disciplines in order to maximise existing modules and programmes for delivery a diverse range of industry markets
- Management of the CPD offering to clients and students to ensure quality of offering and efficient delivery of this service.
- Working with the relevant subject matter experts and stakeholders to create CPD events and to work with the PET Manager to ensure the efficient operation of the PFP & CPD development
- Evaluation of PET programmes in conjunction with the PET Manager and client companies and students
- Working with NCI Learning and Teaching (NCILT) colleagues to ensure best practice at all times in the delivery of blended programmes

• Project Management

- The ability to scope, lead and manage a project from inception to 'business as usual' fruition. This will include such things as new programme development, development of online delivery projects and development of other initiatives for the PET market.
- When large scale delivery programmes require additional support to work with the PET Manager on the logistics of same where necessary
- Lecturing and Delivery of Taster Sessions
