

# Registration Form for International Students January 2026

## All new International Students must complete this form

Completing this form applies to international students holding an unconditional offer, who are already living in Ireland or students who are travelling to Ireland. It is required to ensure that students are:

- Registered for their course and issued their student card.
- Scheduled for their welcome meeting and campus tour.
- 3. Issued their letter to register with immigration.
- 4. To book the airport shuttle, if required.

The completed form must be emailed before travelling and by the deadline of 9th January 2026 to <a href="mailto:internationalsupport@ncirl.ie">internationalsupport@ncirl.ie</a>.

#### Free NCI Airport Shuttle

The NCI Airport Shuttle Service is available to new international students. To book it, the registration form must be submitted 5 working days prior to arrival and the service is available from:

- Dates: 5th to 12th January 2026
- Times: Flights \*scheduled to arrive into Dublin between 06:00 (6am) and 20:30 hours (8.30pm). The NCI Airport Shuttle is not available to book outside of these hours.
- · Drop off: to your accommodation in Dublin

\*We know that sometimes flights can be delayed beyond the scheduled arrival time. The drivers will know when flights are delayed and will wait.

### **Emergency Contact** and Insurance Details

International students must provide this information so that it is available where we consider a student's health, wellbeing or welfare to be at risk.

Usually the emergency contact will be a parent or guardian but can also be another family member or friend.

Please ensure that your emergency contact is;

- aware that they have been nominated and that their contact details have been given to NCI for this purpose;
- readily contactable please provide a phone number so that contact can be made quickly;
- 3. if possible, able to speak English.
- 4. Medical Insurance is requested by Immigration. Please, attach your Medical Insurance Policy when submitting the Registration Form.

#### **Frequently Asked Questions**

- Q. I am already living in Ireland, do I need to complete the Registration Form?
- A. Yes it is needed so you are registered for your course.
- Q. I am not booking the Airport Shuttle service do I still need to complete the Registration Form?
- A. Yes it is needed so you are registered for your course.
- Q. Can I submit the registration form if I do not have an unconditional offer?
- A. No, you must meet all NCI entry requirements before filling out the registration form.
- Q. Can I submit the registration form if my visa has not been approved yet?
- A. No, you will need to wait until your visa has been approved.
- **Q.** Do I need to submit the form before travelling?
- A. Yes, you need to submit the form to be scheduled for your Welcome Meeting and NCI Airport Shuttle Service, if booked.
- Q. Do I need to have booked my accommodation to submit the Registration Form?
- A. No, it is not required.
- Q. Do I need to submit my accommodation details?
- A. Only if you book the NCI Airport Shuttle Service.
- Q. I have booked my accommodation for an address just outside Co Dublin.

  Can I book the NCI Airport Shuttle service?
- A. No, the service is only available for accommodation booked in Co Dublin.
- Q. Can I get student letters from NCI before the Welcome Programme starts?
- A. No, letters for new students starting at NCI Students will only be available after the welcome programme starts.
- Q. My flight is scheduled to arrive in Ireland after 20.30hrs. Can I still book the Airport Shuttle?
- A. No, you will have to make your own way to your accommodation.
- Q. Are there other transportation options to get from Dublin airport to my accommodation?
- A. Yes, you can view <u>travel options</u> to and from the airport on the Dublin Airport website.
- Q. Where can I find more information about preparing to travel to Ireland, what to pack, how much money to bring, etc?
